

2024 Communications between the independent directors and the head of internal audit and the CPAs

1. Internal Audit Supervisor :

- The Audit Supervisor submits audit reports to each independent director for review on a monthly basis and holds an annual meeting to discuss internal control deficiencies and related issues.
- Attended all six board meetings in 2024, presenting audit findings and improvement follow-up reports directly to independent directors.
- Attended two Audit Committee meetings in 2024, reporting directly to independent directors on the results of internal control self-assessments and the formulation of the internal audit plan.
